

#### **Project Summary**

The title of the project is "To reduce Poverty by Increasing Knowledge Capacity" and its mainly scope is "Business and Human Right". Total project duration is 6 months to 2 year whether first period is from 26<sup>th</sup> July 2015 to the end of January , 2016 ad the second period is February 2016 to July 2017. Mainly 80% of project fund is donated by the ASEANSR Network Ltd and others 20% will be funded from co-founders SMART Group of Companies, MOGSS and Chuan Huat International Pte Ltd. After six months, the last project period will be go by Ray of Hope's own fund, the former co-founder fund and others sponsorship.

In this project, the title is mainly focus on general knowledge on profitable business, harmless living and human rights. If we flash bac in our community, there are many business issues about human and right, dangers to natural disasters and economic challenges. There are many human right violations such as forced migration, labor exploitations, child labors, gender inequality, human trafficking. So this project will help to protect the local work survival of locals for business, safety, health and prevention of natural disasters. The mainly targeted areas are Yangon and Bago Division, target ages are 10-18 and 19-55.

We target to implement in three main outputs which are knowledge sharing by publication, communication campaign and awareness training. Main activities based on outputs are illustration of cartoon book and pamphlet publishing and radio broadcasting about those books. Or second one, workshop surveys, case study based on regional issues, and group discussion as communication campaign. For the last one is by demonstration a play performance and presentation of gallery showroom as awareness training. Also our co-funder will help with the project funds, material supports and volunteer participation in our project. All the operation process will run stage by stage as showed in activity list and Gantt chart.

Finally, to meet our purpose and objective, we will review and evaluate analysis on the project every 3 months. We expect and ensure that the community will benefit through this project and meets the purpose and exception in positive results.




