### **E. Short Project Summary**

Indonesia Business Council for Sustainable Development (IBCSD) and the Indonesia Chambers of Commerce and Industry (KADIN Indonesia) has supported Yayasan Penabulu since end of 2014 to prepare the Indonesia Vision 2050 as a business view of a sustainable and sustaining civilization by 2050; which aims to tackle the harder challenges of laying out actions that must be taken, starting now, to make that vision a reality. The project amidst dramatic evidence "business as usual" is no longer an option in the face of a climate changing more rapidly than predicted, declining key ecosystem services, food and energy insecurity for many, and a financial crisis sparked mainly by short-term thinking and poor governance. The report will feature a set of agreed "must-haves" as well as the business potential that lies between challenges that may come. Process and formulation of the report will be donein two primary project phases with following outcome documents:

<u>Phase One:</u> consist of 2 major documents consist of reports on (I) Business as Usual or megatrend report, (2) Indonesia Vision 2050 and the Pathways to 2050 with detail business opportunities that may arise. Both documents, Indonesia Trend 2050 and Indonesia Vision and Pathways 2050 had been finalized

<u>Phase Two:</u> The following phase will consist of 2 major documents which are (3) the Action Plan 2020 and the (4) Changing Pace. These two major goals will consist of more dynamic process such as collaboration, consultation, analysis and advocacy to various stakeholders of Indonesia Vision 2050. This project propose for supports to the implementation of Phase Two, especially for the preparation of Indonesia Corporate Action Plan 2020.

To develop consensus on a joint corporate action plan Indonesia 2020 about collective steps that must be taken to achieve the vision of sustainable development Indonesia 2050 and communicate vision, road map and the corporate action plan to the government and other key stakeholders as well as to general public.

# Was the Purpose achieved? If not, give reasons. Please state your sources of information.

The preparation of action plan document 2020 which involving the parties is the achievement of this project. The process of drafting conducted through various activities such as focus group discussion and workshop that has been done. These activities are conducted to get input and feedback from the parties in the preparation of Action Plan Indonesia 2020.

The writing of the Action Plan Indonesia 2020 document is implemented after taking a look to the inputs and results of the identification. At this time, the document status is in the finalization stage. The inhibition of the process of compiling this document due to quite difficult to get input from the parties,

especially from the company in the FGD forum and Workshop series that have been planned in the proposal.

To anticipate this, a personal meeting (in-depth interview) will be held to target participants who have been targeted to be participants in the FGD and Workshop. The mechanism of the In-depth interview to the parties has an impact on the timeline of completion of the Indonesia Action Plan document in accordance with the specified requirements.

#### Did any external factors contribute to the achievement of the Purpose? Please describe.

External factors that contribute positively to document compilation efforts are the seriousness and commitment of Indonesia Business Council for Sustainable Development (IBCSD) which provides many opportunities for executors to dialogue informally with the companies that become members.

In addition, Penabulu network spread in various circles also provide positive contributions and help in providing input discourse and the route that must be arranged to prepare Action Plan 2020.

# Were there any significant changes made to the project design after the commencement of the project (outputs, activities, budget, duration etc.)? Please describe the changes.

In general, there are no changes in project in approved proposal. It is just that there is a bit of time shift from the activity being run. As stated above, that because it is quite difficult to collect companies that will be involved in the workshop, so that impact on the timing of execution and changes in activity schemes. Efforts which have been made to anticipate this is to conduct informal discussions with the parties (In-depth Interview).

Nevertheless, there are benefits gained by in-depth Interview. Although the time has changed, but the positive impact is actually able to discuss more deeply with the parties.

Informally the workshop/FGD has been held 2 times:

- I. April 18, 2017. Workshop for Understanding the Carbon Disclosure Report was held in cooperation with IBCSD, CDP and Penabulu Foundation. This workshop aims to (I). Explains how to encourage the private sector to contribute to Emission reduction; the contribution of the private sector in emission reduction is part of the Indonesian government's mandate in the Indonesian Intended Nationality Determined Contribution (INDC). Report of activity results attached.
- 2. March 16, 2017. Workshop for Human Rights on Sustainable Business was held. The topic raised in this workshop is to increase the business sector's role in sustainable development issues: Exploring Alternative Public-Private Partnerships. The purposes of this Workshop are: (1). Sharing good business practices related to environmental and social sustainability issues. (2). Increasing private sector awareness in sustaining a sustainable economy (3). Raising awareness of sustainable business through a collaborative approach to conflict resolution.
- 3. Workshop for Indonesia Corporate Vision and Pathway 2050 and Indonesia Corporate Action Plan 2020. The results of this workshop get input on the document Indonesia Corporate Action Plan 2020.

#### G. Please describe any unplanned consequences from the project.

With the level of difficulty experienced in gathering the parties to get input in the preparation of documents in the form of official forums, the implementation of both workshop and FGD activities mostly done with a personal approach through In-depth interview. The consequence of this change of strategy is the change of set schedule scenario; the project will take longer than the target according to the project execution schedule.
