The ASEAN Responsible Business Forum 2018 brings together over 30 panellists who are business and civil society leaders, government officials and subject experts from the region and beyond to present the business case for responsible and inclusive business in ASEAN.

They will address key challenges faced by ASEAN including:

- Advancing responsible and inclusive business in the region;
- Micro, small and medium-sized enterprise (MSME) development;
- Business integrity and anti-corruption;
- Climate change and environmental sustainability; and
- Human rights due diligence in the supply chains.

These challenges will be addressed in five expert-led panel sessions over the two-day Forum, which seeks to identify practical strategies and share good practices that can be scaled up and replicated in the ASEAN region.

LAUNCH OF THE ASEAN MENTORSHIP FOR ENTREPRENEURS NETWORK (AMEN)

The Forum will see the launch of AMEN in Singapore. A flagship of the ASEAN Business Advisory Council, the programme aims to facilitate the scaling up of micro and small enterprises in the ASEAN region through mentorship by a pool of entrepreneurs, business practitioners and academics in priority sectors such as digital economy, trade and industry and agripreneurship.



FINDINGS FROM STUDY ON BUSINESS INTEGRITY IN ASEAN

The findings of the 2018 study on Corporate Disclosure on Business Integrity in ASEAN will be presented at the Forum. This study assesses the public disclosure practices on business integrity and anti-corruption programmes by the 50 largest companies in five ASEAN countries – Indonesia, Malaysia, Philippines, Singapore and Thailand, and compares their latest performance with that of the 2016 study.



WORKSHOP ON BUSINESS AND HUMAN RIGHTS

This half-day workshop, co-organised by the ASEAN CSR Network and Oxfam, is designed for companies in ASEAN, particularly medium to large enterprises. Companies will learn how they can use the UN Guiding Principles on Business and Human Rights (UNGPs) as a framework to bring business and human rights from plans to action. As seats are limited, registration is on a first-come first-served basis.
